This certifies that

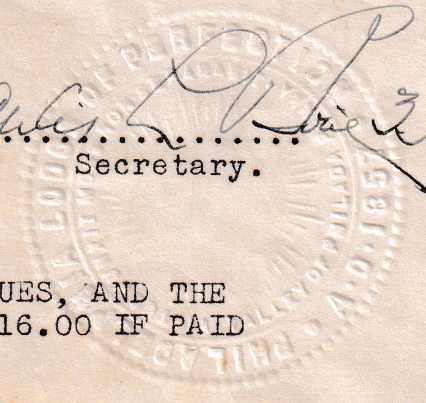
Brother... *Samuel B. Ashmead* ...
